Transfer from LBI ...

LBI

- LBI is a Winding-up Board for the fallen bank of Landsbankinn
 - LBI was founded on the base of the Emergency Act (no. 125/2008)
- The role of LBI is:
 - to wind up the bankruptcy estate of the old Landsbanki
 - settle the assets and liabilities of the old Landsbanki
- After the bankruptcy the state acquired Landsbankinn

- There are two Landsbankinn!





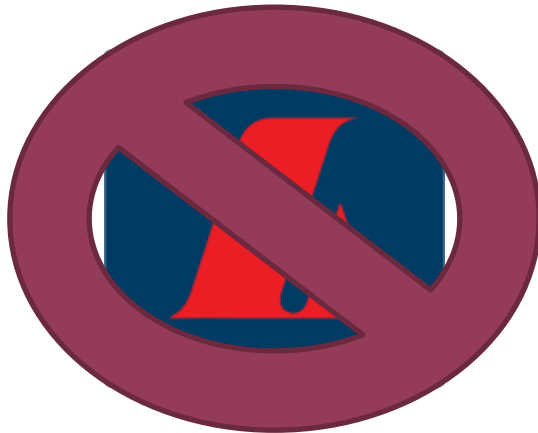

- In September 2016 – Hugvit sends us technical data



THE NOTIFICIATION

- In January 2018, the National Archives of Iceland received the notification
 - From **HUGVÍÐ** and **LBI**
- The notification was accepted in February 2018.
 - Only few employees left at **LBI**



DELIVERING SIP

- Hugvit had already started making the SIP in January 2018.
 - They were our main contact in this project
- June 2018
 - SIP delivered
 - Testing the SIP got delayed.

TESTING OF THE SIP – THE TEST SHEET

What was tested?	Finished
Same tables should be in the SIP as are specified in Delivery terms	Yes
Does Delivery terms contain contracts or some sort of connection which needs to be looked at?	Yes
Description of tables and columns in tableIndex should match the data in the tables and columns.	✓
Does column contain a code (which needs to be explained)? Please check if it is properly explained.	✓
A field which contains text/string must not contain marked text which cannot be interpreted	✓

Tips

- The tips were mostly because some columns were always empty (contained no data)

Remarks

- Most of the remarks were because something wasn't described correctly
- Type of remarks:
 - Columns with the same description
 - Lack of description
 - Format/marked text not explained
 - Abbreviations not explained
 - File Format

TESTING OF THE SIP – THE TEST SHEET

What was tested?	Finished
Estimation of number of documents which could not be converted or were missing from the SIP	Yes
Estimate the readability of documents in the SIP	Yes
Estimate whether first empty page or empty pages are due to conversion errors	Yes
Estimate whether connection between document and documentation is correct (Does each document connect to a case?)	Yes
Check if mandatory or other kind of activity is present	Yes

Remarks because of unconvertable documents

- 59 documents couldn't

Remarks because of Documentation

- Name of document is not according to heading/title
- Wrong document date
- Document date was missing
- Received date of document missing

Transfer from LBI ...

THE SOLUTION

- There was no way we were getting the errors in the SIP fixed
- We asked for a list which explained abbreviations, formats and marked texts.
 - 26 pages of abbreviations!



ADDITION TO THE SIP

- The national archives of Iceland added the following documents to the SIP
 - Instructions with the SIP
 - List of abbreviations
 - The test sheet
 - Updated:
 - archiveIndex
 - contextdocumentationIndex



INSTRUCTIONS WITH THE SIP

Leiðbeiningar vegna GoPro Kröfur

Þessi vörsluútgáfa er ófullkomin að því leiti að það eru ýmsir annmarkar á henni. Þjóðskjalasafn þurfti að samþykkja hana svona því það er verið að loka Slitastjórn Landsbankans og það eru engar lýkur á því að við getum fengið þetta betra.

Það tókst að fá skammstafanaskjal sem lýsir helstu skammstöfunum og var það sett inn í contextDocumentation.

Skjalið sem sýnir athugasemdir vegna prófunar á vörsluútgáfu verður látið fylgja með í vörsluútgáfunni.

Eftirfarandi var lagað af starfsmanni þjóðskjalasafns:

- Skammstafanatöflu bætt við vörsluútgáfuna
- Þessu skjali bætt við vörsluútgáfuna
- Yfirferð á vörsluútgáfu (þ.e. athugasemdashjál vegna prófunar á vörsluútgáfu) bætt við.
- Í archiveIndex var archiveInformationPacketType breytt í true þar sem þetta er lokaafhending
- Ekki var hægt að laga lýsingar á svæðum og verður að láta duga þær lýsingar sem eru til staðar. Á einhverjum atriðum er tekið í skammstafanatöflunni.
- Ekki var hægt að laga umbreytingarvillur eða laga ólæsileg skjöl.
- Ekki er alltaf hægt að leita eftir dagsetningu skjals. Dagsetning var mjög oft röng í Attachments töflunni og stundum í Documents töflunni. Ef skjal finnst ekki eftir dagsetningu, leitið þá eftir öðrum lýsigögnum.
